Re: New Ontario Laboratories Information System (OLIS)
Withdrawal and Reinstatement of Consent Forms

The Ontario Laboratories Information System (OLIS) Withdrawal and Reinstatement of Consent forms have been updated to reflect the Ministry of Health and Long-Term Care's (ministry) custodianship of OLIS. Through these forms, patients may exercise their right to block or reinstate access to their personal health information within OLIS.

Your office may have outdated OLIS Withdrawal and/or Reinstatement of Consent Forms:

The ministry requests physicians and health care providers who order laboratory tests to immediately discontinue use and discard any remaining OLIS Withdrawal of Consent Forms and/or Reinstatement of Consent Forms in your possession.

The ministry has distributed OLIS Withdrawal of Consent forms and supporting documents to OLIS-participating community laboratories and specimen collection centres. These documents will also be available on the Government of Ontario Central Forms Repository:
